Election for District President

- 1st Vice President Vince Harman presided over the election for District President.
- One candidate: Mike Gibson
- Elected District President is Rev. Mike Gibson, elected by verbal acclamation.
- Chaplain Michael Hall prayed over President Gibson and Kathy Gibson.

2:24 pm District President's Address w/Q&A

- You are part of something bigger: Pacific Southwest District, LCMS, part of a church body tied to international bodies.
- Our Purpose: To effectively resource congregations and schools for transforming lives and making the Great Commission REAL!
- Illustration to describe where we are now: "A New Place on the Beach." If caught in a riptide you cannot fight to go back to the same place you left. Instead, the current carries us parallel to shore until we are released and dropped off at a new, unfamiliar place on the beach.



- We, along with the rest of the world cannot go back to where we were at the beginning of March 2020. The new place on the beach is a place God is waiting to greet us and invite us into a new thing that He is doing.
- Cf. John 21:3 Peter goes back to fishing after Holy Week and Easter Sunday.
 Despite the disciples catching nothing, breakfast is provided for them because of Jesus.
- There can be a tendency for us to say, "I don't like this..." hostility, marginalization; temptation to turn inward and protect God's truth from the unbelieving hoards.
- Most of the history of Christianity has been in a hostile and resisting culture. This
 is a hard season yet it is into this environment in the past others before us
 forsook everything for the sake of what we proclaim, teach and confess so it may
 be proclaimed to the world.
- This is a moment for us! Temptation is to relax; instead, put our foot on the accelerator.
- Three goals for our time together:
 - Opportunities and Challenges
 - We are a diverse place population, culture, worldview. Over 300 congregations, over 150 schools, 6 major metropolitan areas with 36 million people and everyone in between. PSD is the green, growing edge of the Mission Field.
 - 54 congregations cannot afford full time pastors, others are on the verge.
 - 26 congregations are actively seeking pastors.
 - Thank God for COVID for what it has meant for our schools.
 - Partnerships and Resources
 - "It takes all kinds of churches to reach all kinds of people."
 - West Coast DPs spend every Monday morning in the Word, praying and connecting with each other.
 - West Coast Districts work together to orient new pastors in MAP for West Coast context of ministry.
 - The Mission Training Center is a way for pastors to have partnerships from well-trained lay people – doing what used to happen with the Licensed Lay Deacons and Parish Ministry Assistants. We have also partnered with Concordia University Irvine as they help us evaluate instructors, look at curriculum, syllabi, etc.
 - 100 in 10 Initiative between now and the 100th anniversary of the PSD (2030-31) God would use all of us together to begin 100 new ministries in our District.
- A training resource was given to all delegates "The Great Sending" and commended for use in congregations



- The Lutheran edition of Rooted is commended to the Convention partnership from outside our church body in the Global South.
- Strategic Partnerships Circuits, as well as congregations together are joining together motivated by mission instead of fear of closure.
- Our schools are able to build bridges into our communities. When parents trust you with their babies you have an opportunity to reach entire families and establish a legacy of for the Gospel.
- We are looking to build sustainable ministry models. A model for when congregations are struggling:
 - Retain is this a place we want to retain? Is it a place we don't want to give up a foothold?
 - Remodel Sometimes a new type of ministry needs to go into an existing place – e.g., LuTEC in local congregations with pastors as the theology teacher for the students.
 - Replant go into a community, build relationships in the community, replant a ministry in this community that engages the community
- Financial partnerships have been significant since 2018.
 - PSD provided \$200,000 in COVID assistance to congregations and schools.
 - o partnered with LCMS to give \$126,000 through Soldiers of the Cross.
 - The PSD Board of Directors established a fund of \$45,000 to assist nonrostered teachers in our Lutheran Schools to complete the Teacher Colloguy Program.
 - Mission India gifts combined through our District, congregations and individuals totaled \$488,000. A video on Mission India was shown.
 - PSD Regional Mission Councils gave Mission Development grants totaling \$1,823,000 to help advance the Gospel
- PSD had a perfect audit with no comments.
- The financial situation is that our giving is more than a million dollars a year less than budgeted. The gap is made up through special gifts and bequests that cannot be counted upon year by year. President Gibson invited the Convention to continue to support the district in order that they can better serve the ministries of the Pacific Southwest District and for to pray that God would do abundantly more among us than we could ever ask or imagine.
- Church worker development is an urgent need as a large number of pastors and church workers are facing retirement and are not being replaced relative to the level of need with new church workers. We are praying for church workers for recruitment and retention.
- Our Work at Convention
 - President Gibson gave thanks to all who are willing to serve by letting their names stand for election. He is also thanking those who are concluding service. Thank you to those who said yes to nominations. Thank you to the Nominating Committee.

- A video highlighting partnership ministries in southern California was shown: Rev. Kyle Blake, The Gathering, Long Beach and Rev. Kevin Kritzer, Bethany, Long Beach; Rev. Nathan Huse, St. John's Orange, deployed to Peace Tustin.
- Ephesians 3:20-21 emphasis on "within us." Partnership of Father, Son & Holy Spirit is the power at work within us.
- Congregations who are candidates for partnership in ministry breakdown into three categories: 2, 20, and 80.
 - Among Protestant congregations, according to "Better Together Making Church Mergers Work":
 - 2% of all congregations vote to close each year.
 - o 20% are growing and ready to move forward.
 - 80% have plateaued or are declining.
 - o 100% of congregations are candidates for partnership in ministry.
- We are one church and God is working through us all.



- Principles of partnership include concentrated prayer, mutual respect, intentional commitment, focused clarity and constant celebration.
- There are many types of partnerships: cooperative planting/replanting, shared ministries and workers, co-located congregations, multi-point networks or parishes, and mergers.

- Attending the many district conventions allow Pres. Harrison many opportunities to see how the LCMS functions at large.
- 9 min Synodical Video
 - Various responses by St. Louis area congregations and schools to the pandemic
 - \$1 mil life grant for congregations doing life ministry
 - \$1.5 mil soldiers of the cross distributed
 - Doxology Take Heart Retreat benefit to pastors struggling during after COVID
 - Lutheranism around the world (including Africa) continues to grow LCMS is
 - resourcing other Lutheran church bodies around the world
 - New project in Europe, Rev. Dr. John Bombaro working to establish a seminary in Eurasia
 - "We preach Christ Crucified" (1 Corinthians 1:23) is the 2023 Synod Convention Theme
 - As the LCMS, we for 175 years have preached "Christ crucified" and will for the next 175
- COVID Blessings and Challenges
 - o For the first time in 15 years the dollars to Synod went up by \$1 mil
 - Online Communion discussion was handled relatively peaceably by the COP but will be discussed at the Synod Convention.
 - LCMS is a diverse group of people.
 - Worked with the Alliance Defending Freedom to allow freedoms during COVID.
 - 963 "Soldiers of the Cross" grants were distributed—average \$1k \$2k.
 - 30 "Take Heart!" Doxology retreats for soul care.
 - 7-03 Task Force "CUS Lutheran Identity and Mission"
 - Probably will be contentious, by Pres. Harrison's own statement.



- Transfers all of the finances, property, etc. to the hands of the individual universities.
- Cited Concordia University Texas' desire to leave the Synod, but remain aligned.
- New Concordia presidents: Dr. Bull (CUNE), Dr. Dawn (CUC), Rev. Dr. Friedrich (CSP), Dr. Thomas (CUI)
 - CSP free tuition for church workers
 - CUI best system of governance everything goes through the theology department
 - Mentioned CUW and the fact that the presidential search brought national news attention.
 - Pres. Harrison believes we have the strongest anti-racial doctrine.
 - Pres. Harrison is currently reading How to Be an Antiracist by Ibram X.
 Kendi describing many aspects of the world as racist.
 - Pres. Harrison feels that he cannot allow students going through our schools (Concordia System) who believe the school is racist or bigoted.
- Rev. Dr. Tom Egger at Concordia Seminary as president
- Formal conversations with the Malagasy Lutherans a church body of 4.5 mil members Africans only count those in church.
- Religious Freedom in Finland-
 - Christian view of marriage, co-published with Lutheran Heritage Foundation
 - LCMS drafted a protest letter
 - Won the case approximately a month ago (May 2022)
- Entering into church fellowship with "Evangelical Lutheran Church of Sudan/South Sudan"
- Ukraine
 - Ongoing support including space in Wittenberg and a Ukrainian church plant is being established
- LWML gives thanks for all of their work
- Women have superpowers
- Can have children
- Can make their husbands better
- Sudden Onset Gender Dysphoria
 - 5000% increase among young women
 - o "we are living in an age of lunacy"
 - Instead of asking young people, "what do you want to be;" he is going to ask "how are you going to serve"
- Office of International Mission
 - Our missionaries are down
 - 12 staff for 300 missionaries and families



- Hope to add 180 more missionaries in five years
- o All missionaries are funded on average for at least 1 year
- Gary Tiews in Iowa raises approx. 8-10 mil dollars a year for missionaries around the globe
- Livonia Lutheran Project
 - 4 anonymous men learning about Jesus
 - o An explosion of Lutheranism in Pakistan, Romania, Italy
 - 1500 converts from Islam to Lutheranism
- New Spanish Lutheran Hymnal five Divine Services, 250 new songs and hymns, more hymns than LSB, available on an app within a year

Question and Answer

- Q: Reference to three resolutions considering enlarging the routes to ordination and reconsidering the licensed lay deacon program; how should we vote on these resolutions?
- A: Licensing of Lay deacons for Word and Sacrament ministry would be in opposition to the Augsburg Confession;
 - The sainted Herb Mueller worked hard to ordain licensed lay deacons through SMP

Not sending guys under 40 for a full seminary education is problematic. Shortage of seminary trained pastors.

The culture of moving to online program is the cause of the declining residential seminary.

Ref. Wichita decision of '89, rejected by 74% - lay man could take part in worship and even lead a prepared sermon.

- Q: My understanding is that the Concordia Seminary incoming class is about 20; ref. to Pres. Gibson's report and decline of pastors; what is Synod's answer to the decline of pastors?
- A: Retention. Investing in pastors through programs such as Doxology. Lay leaders, serving as lay readers will have to fill the gaps by reading pre-written sermons and leading worship. Synodical response is in progress—seriously looking at. Plea at the National Youth Gathering.
- Q: A lot of disaster response and crisis discussed; is there an emphasis or effort for everyone's well-being, not just pastors, for general wellness in our communities?
- A: Synod website has a list of resources. We could always do more. Let the Synod know what ways they can help.
- Q: I love our church and synod, various issues (including internal strife in the Synod), a potential future pastor, "should he enter the ministry with the current realities?" How would you respond?
- A: "Suck it up." The Synod is calmer now than 30 years ago. Remedy sexual sin by keeping pants on. The COP is calmer than things have ever been. He does not believe we are a Synod type of synod. Being a pastor is the greatest job in the world and "there ain't no perfect church in the world."

- Do you know the LCMS?
- Will you be the LCMS?
- Gospel DNA: Five Markers of Flourishing Churches
- The Lutheran Churches in the global south are flourishing what can we learn from these churches?
- As Newman studied these churches, he recognized parallels with the origin of the LCMS
- Isaiah 51: Remember the rock from which you've been cut—remember who we are—remember our identity in Jesus Christ
- It is in our DNA, because God has implanted it into us
- "In 1852, the LCMS voted to send workers to 'give attention and spiritual care not only to the German emigrants in California but also to the great number of



Chinese who were immigrating there." - what was the motivation for the LCMS to care about these immigrants?

- In 1856, Pastor H. Fick appealed: "If we are to preach the Gospel in all the world according to the apostolic commission, ..."
- In 1859, Mrs. Elizabeth Schreiber, wrote to Walther: "I regret to note that so many of the sects are dominant here while my dear mother church must take a backseat..."
- This stirred the conscience of Walther, such that he posted it in the Der Lutheraner
- Where did this passion come from?

Five DNA Strands

- People
 - A love for people
 - Passion for the welfare of people's souls
 - Predates the formation of our Synod
 - CFW Walther "Bringing Souls to Christ: Every Christian's Desire and Duty" (1842)
 - "The Christian looks upon his neighbor with sadness... if he does not know the gospel..."
 - Love for others is inseparable
 - "no one should say I am not a pastor, preacher, or teacher...
 Christian you are baptized... you are called to be a priest of God"
 - "the Christian church is a great mission house..."
 - Walther had a passionate desire for all to be saved
 - People matter!
 - The challenge: How is your heart doing? Are you more afraid of people than you love them? Are you too task oriented to love them?
 - As a Church, we lift up the narrative of the Gospel of Jesus Christ, we love the people for whom Jesus died
- Multiplication
 - A commitment to sharing the Good News
 - Rev. Dr. Friedrich Pfotenhauer missionary, president of the MN district, and later president of the LCMS (1911-35)
 - These were "self-sacrificing men their hearts throbbing with the love of Christ and his people."
 - 1917 address to the Milwaukee convention although we are living in such troubled times... we Christians may not become slothful or discouraged and be active...the signs of the times should urge us to labor incessantly and with all our powers.
 - Extension of the Kingdom is what Pfotenhauer emphasized
 - 14 congregations and 4000 people in 1847 to 4000 churches and 1 million members in its first 70 years (1847-1917)



- The LCMS planted one new church every week for its first 100 years
- In 1847-1916 for every 2 LCMS churches in existence, one new LCMS church was started
- In 1917-1965 for every 9 LCMS churches in existence, one new LCMS church was started
- In 1966-2015 for every 4000 LCMS churches in existence, one new LCMS church was started
 - We forgot who we were, we forgot what we did at first
- When the Word is proclaimed, God equips His people
- o Matthew 25 what does it mean to be faithful the parable of the talents
- Not just protecting and preserving, but promoting and proclaiming

BYLAWS

1.0 DISTRICT OFFICERS

- 1.1 The district shall elect a president; first, second, third and fourth vice presidents; a secretary;a treasurer; and a circuit counselor from each authorized district circuit.
- 1.2 The district shall also elect:

AA board of directors
A Church Extension committee chairperson
A committee on constitutions

1.3 Elected Officers

- 1.3.1 No one in the district, or between the Synod and District, shall hold more than one elective office; or hold more than two offices, although one or both be appointive; orever hold two office of which one is directly responsible for the work done by the other.
- 1.3.2 No one shall be elected to more than one district office.
- 1.3.3 No more than two executive officers shall be elected from any one congregation. The executive offices shall be understood to include the president, the vice-presidents, the secretary, the treasurer, and members of the Board of Directors.
- 1.3.4 The term of the office for all elected to district offices shall be three years.
- 1.3.5 The offices of the president, the first vice president, the secretary, and the treasurer of the district shall be without limitation as to reelection.
- 1.3.6 All other elected officers, members of the board, and elected committee membersmay serve a total of no more than three successive terms in the same positions.
- 1.3.7 Any officer, member of the board, or elected committee member may be elected tohis previous position after an interval of three or more years.
- 1.3.8 Any officer or member of a board, ineligible for reelection, may be elected orappointed to any other position.
- 1.3.9 All new officers, the board, and committees will assume their duties in the second month following the convention elections, and the current officers and the board shallcontinue to serve until that time, except that members elected to the board of regents of Concordia University Irvine take office at the close of the district convention at which they are elected. (Synod Bylaw 3.2.4.



- 1.4.1 A vacancy in the office of the presidency shall be filled by the first vice president.
- 1.4.2 A vacancy in any vice presidency shall be filled by advancing the lower-ranking vice presidents. The remaining vacancy shall then be filled by the president from the nominees left after the previous election, according to thenumber of votes received.
- 1.4.3 A vacancy in the office of secretary or treasurer shall be filled by appointment by the Board of Directors.
- 1.4.4 A vacancy in the office of circuit counselor shall be filled by appointment bythe district president.
- 1.4.5 A vacancy in any other office shall be filled by appointment by the districtpresident in consultation with the appropriate body.
- 1.4 Procedures for Nominating and Electing
 - 1.4.1 All officers shall be elected at each convention.
 - 1.4.1.1 President

1.4.1.1.1 Nominations

- 1.4.1.1.1 Six months prior to the District Convention, the secretary of the district will request from all congregations of the district the nomination of up to two ordained ministers from the clergy roster of the Synod for the office of District President.
- 1.4.1.1.2 The candidates receiving the three highest total number of nominations who are willing to serve if elected shall be n the ballot for District President.
- 1.4.1.1.3 The biographical information of the three nominees as well as mission and vision statements from the candidateswill be printed in the convention workbook for prayer and study by the delegates.
- 1.4.1.1.4 The election of District President will occur during the firstsession of the District Convention.

1.4.1.2 Vice Presidents



1.4.1.1.1 Candidates for these offices shall be listed on the Clergy Roster of The District and shall hold membership in a congregation of the region represented.

1.4.1.2.1 Vice presidents shall be elected to serve the following

- 1.4.1.2.2 Nominations for each of the four regional vice presidents shall be made by the congregations within each region. Six months prior to the District Convention, the district office shall supply to the congregations of each region a list of eligible ordained ministers who are members of member congregations of the region. Each congregation may nominate from this list two ordained ministers. The four nominees for each region, who receive the most nominations and, who with their consent to serve, shall be placed upon the convention ballot and information about each candidate shall be published prior to the convention.
- 1.4.1.2.3 Following the elections of the four regional vice presidents, another ballot election shall be conducted to determine, by majority vote, the positions of the vice presidents. The names of the four vice presidents shall be listed on the ballot in alphabetical order without reference to their regions
- 1.4.2 The Circuit counselors Visitors shall be elected in the following manner: according to the procedure outlined in LCMS Bylaw 5.2.1 5.2.2.1 (2019 LCMS Handbook)

1.4.2.1 Nominating

1.4.2.1.1 Every voting congregation of each circuit shall nominate as candidates for the office of circuit counselor two men from the clergyroster of the Synod. Nominations may also be suggested by the district president." The nominations shall be made at least six months prior to the elections and shall be submitted to the

current Circuit Counselor.

1.4.2.1.2 Selection of the circuit counselor shall be done in a Circuit



Forum convened by the circuit counselor. Each congregation of the circuitsends a pastoral and lay delegate who votes for the circuit counselor.

1.4.2.2 Ratification

- 1.4.2.2.1 The convention shall have the right to alter the slate by amendment.
- 1.4.2.2.2 The convention shall then ratify the slate of circuit counselor, which ratification shall constitute election.
- 1.4.3 The district representative on the Synod's Committee for Convention Nominationsshall be elected in the following manner: according to the schedule and process in LCMS Bylaw 3.12.3 3.12.3.3.
 - 1.4.3.1 The District Convention shall elect a representative to serve on Synod's Committee for Convention Nominations.
 - 1.4.3.2 The district will be informed by Synod whether it is to elect a church worker(ordained or commissioned member of the Synod) or a layperson. The alternate should be in the same category.
- 1.4.4 Board of Regents, Concordia University Irvine shall be elected in the followingmanner:
 - 1.4.4.1 The district shall elect four members for the Board of Regents, Concordia University Irvine—one ordained minister, one commissioned minister, and twolay persons.
 - 1.4.4.2 Members of the Board of Regents shall serve three-year terms, renewabletwice.
- 1.4.5 The nominating and election procedures shall include the following:
 - 1.4.5.1 Prior to each district convention each regional vice president shall appoint from his region at least two ordained ministers, two laypersons, and two commissioned ministers to stand for election to the District Nominating Committee. The District Convention shall elect from each region one pastor, one lay person, and one commissioned minister who shall serve on the 12- member Nominating Committee for the following District Convention. The committee shall choose its chairperson at its first meeting.
 - 1.4.5.2 The committee shall elicit from all nominees for office, prior to the



convention, an indication of their willingness to serve if elected. The slate of nominees, including the qualifications of each person nominated, shall be included in each convention packet, and these materials shall be mailed distributed to each lay delegate, pastoral delegate, and to each advisory member delegate and to each pastor at least one month before the convention begins.

- 1.4.5.2.1 Additions to the slate of nominees may be made from the floor byvoting delegates, with the consent of the person so nominated.
- 1.4.5.3 The president shall appoint a committee of nine members—three pastors, twocommissioned ministers, and four laypersons—to conduct and supervise all elections.
- 1.4.5.4 This committee shall have the privilege of the floor at the discretion of the convention chairman.
- 1.4.5.5 A majority of all votes cast shall be required to elect. The result of each ballotshall be announced to the convention.

2.0 BOARD OF DIRECTORS

- 2.1 Shall consist of sixteen members: the president, the four vice-presidents, the secretary, thetreasurer, one layperson and one commissioned minister from each region and the chairperson of the LCEF Board.
- 2.2 Nomination
 - Six months prior to the District Convention, the secretary of the district will request nominations for all board positions with regional representation being achieved as follows: Each congregation in a region will be invited to nominate up to two people for commissionedminister and up to two lay people from their region. All who are nominated must be a member of a parish in their region. The individuals receiving the four highest numbers of nominations from each region will be placed on the ballot for election by the entire convention.
 - 2.2.1 If an elected member of the board would move out of their region changes their membership to a congregation outside their region during their term of office, the position would be vacated and a new candidate from the region would be appointed as outlined in the District By-laws. (this change is necessitated due to Synod Constitution change)
- 2.3 The Board of Directors shall:



- 2.3.1 Develop policies to facilitate the efficient functioning of the district as it carries out itsmission.
- 2.3.2 Be the legal representative of the district and the custodians of all property of the district, and it shall be responsible for the general management of the district, actingon its behalf, between conventions.
- 2.3.3 Employ an Executive Team Leader a Chief Operating Officer to carry out the administration functions of the district according to the policies established by the Board of Directors and under the direction of the district president.
- 2.3.4 Elect, immediately following each convention, a chairperson from the elected Boardmembers, and meet regularly according to its needs.
- 2.3.5 Approve or disapprove of all appeals for money of a general nature to be made tocongregations or individuals, not previously authorized by the district.
- 2.3.6 Keep on file an accurate inventory of all properties, legacies, and other valuabledocuments of the district.
- 2.3.7 Be authorized to draw upon the district treasury for its expenses.
- 2.3.8 Be accountable to the District Convention for all its transactions. Any decisions of theboard may be appealed to the District Convention.
- 2.4 Fidelity bonds shall be provided for the Treasurer, the assistant to the treasurer Chief Financial Officer, and other district personnel as determined by the Board of Directors.
- 2.5 The president and the secretary of the district shall be empowered and instructed to sign all legal documents in the name of the district. The treasurer shall be empowered to sign legal documents in the absence of the secretary, and the first vice president in the absence of thepresident. Other District personnel can be designated by the Board of Directors.

3.0 DISTRICT CONVENTIONS

- 3.1 The district president shall be responsible for the organization of the District Convention.
- 3.2 The convention shall meet during the calendar year preceding the year in which there is anational synodical convention.
- 3.3 Convention Expenses
 - 3.3.1 All congregations of the district shall be urged to include in their budgets the



- convention expenses of their respective pastors, commissioned ministers, and laydelegates.
- 3.3.2 All congregations of the district *are asked to include* in their budgets the assessment for convention general expenses as determined by the Board of Directors.

3.4 Reports and Overtures

- 3.4.1 Reports to the convention by district committees as well as overtures shall be sent to the district president.
- 3.4.2 The district president shall assign overtures to convention committees.
- 3.4.3 The Convention Proceedings shall be maintained as part of the permanent records of the district.

3.5 Convention Committees

Prior to the convention, the district president shall appoint floor committees. The district president shall name the chairperson. Each committee shall select its own secretary from itsmembers.

- 3.5.1 The chairperson of each committee shall arrange for meetings to consider thereports and overtures assigned to it by the district president.
- 3.5.2 Each committee shall consult with the chairperson of appropriate committees, taskforces, and staff concerning ministry related to the committee's subject area.
- 3.5.3 Each committee shall submit its report and recommendations to the convention.
- 3.5.4 Additional convention committees shall be appointed by the district president asrequired.

4.0 DISTRICT CONFERENCES

- 4.1 All professional workers on the Synodical roster shall attend official conferences in accordwith synodical regulations Synod bylaw 4.8.2.
- 4.2 All congregations of the district *are encouraged to include* in their annual budgets the conference expenses of their professional workers.
- 4.3 Conference for All Ordained Ministers



- 4.3.1 The Conference for All Ordained Ministers shall meet annually in the fall and begoverned by its own procedures and bylaws.
- 4.4 Conference for All Commissioned Ministers
 - 4.4.1 The Conference for All Commissioned Ministers shall meet annually in the fall and begoverned by its own procedures and bylaws.
- 4.5 Joint Conference for All Ordained and Commissioned Ministers
 - 4.5.1 A joint Conference for all ordained and commissioned ministers may be called at the discretion of the Conference for All OrdainedMinisters and the Conference for all Commissioned Ministers.
- 4.6 Circuit Visitors' Conference
 - 4.6.1 The Circuit Visitors' Conference shall meet twice a year.
- 5.0 PRESIDENT, VICE PRESIDENT, CIRCUIT COUNSELORS,
 SECRETARY, TREASURER, EXECUTIVE TEAM LEADER, AND
 REGIONAL MISSION FACILITATORS

5.0 DISTRICT OFFICERS AND EXECUTIVE STAFF MEMBERS

- 5.1 The duties of the President, Vice Presidents, Circuit counselors Visitors, Secretary, and Treasurer shall be as outlined in the Synodical Handbook except as supplemented in these Bylaws.
- 5.2 The Vice Presidents shall fulfill their responsibilities as directed by the President.
- 5.3 The executive team leader Chief Operating Officer is responsible for the overall administration of the Pacific Southwest District office, the support, and coordination of the regional mission facilitators. The executive team leader Chief Operating Officer shall work under the direction of the District President. The general duties of the executive team leader the Chief Operating Officer are listed in the job description for the position.
- 5.4 Regional mission facilitators The Executive Director of School Ministries, Mission and Ministry Executive and Chief Financial Officer will serve groups of the congregations and schools of the District, by effectively resourcing them congregations and schools to carry out their mission and ministry. These facilitators Executive Staff members are accountable to the District President for the administration of their positions.



- 5.5 The regional mission facilitators The Chief Operating Officer, Executive Director of School Ministries, Mission and Ministry Executive, and Chief Financial Officer, shall be given calls or contracts with a limited tenure of four years, renewable by the Board of Directors upon recommendation by the District President. The four-year period begins July 1 in the year following each District Convention.
- 5.6 The Board of Directors, in consultation with the District President, may establish, hire, and call other Executive and Support Staff Positions as needed.
 - 5.5.1 The positions of regional mission facilitators and executive team leader shall be filledfrom lists of candidates submitted by district congregations, and members of the Board of Directors and others in the LCMS.
 - 5.6.1 The *job descriptions and* renumeration package for these *all* positions shall be established by the *District President in consultation with the* Board of Directors.
 - 5.5.2 The general duties of the regional mission facilitators these positions shall be as outlined in their separate job descriptions by the District President in consultation with the Board of Directors. for these positions.
 - 5.6.2 The job descriptions for these *all* positions shall be prepared by the District President in consultation with the Board of Directors.

6.0 FISCAL OFFICE

- 6.1 Accounting for all District funds shall be under the direction of the Treasurer. It shall be the duty of the treasurer to work in direct partnership with the Chief Financial Officer of the District:
 - 6.1.1 To maintain all records, which reflect the financial condition of the district at all,times.
 - 6.1.2 To receive all monies for budget and non-budget purposes of the district or Synodand issue receipts for the same.
 - 6.1.3 To deposit all monies in the name of the district in the bank(s) designated by theBoard of Directors.
 - 6.1.4 To issue and co-sign checks covering district expenses.
 - 6.1.4.1 Each of the following persons shall be authorized to co-sign

checks: Controller Chief Financial Officer



President
One of the Vice
Presidents
Secretary

Executive Team Leader Chief Operating Officer

- 6.1.4.2 In case of the absence of the treasurer any two of the above shall beauthorized to sign.
- 6.1.4.3 All persons authorized to sign checks shall be bonded at district expense.
- 6.1.5 To submit all District financial records at least once a year to a licensed and reputable auditing firm as selected by the Board of Directors, or whenever requiredby the Board of Directors.
- 6.1.6 To cause the report of the audit(s) to be submitted to the Board of Directors and tothe District Convention.
- 6.1.7 Be the custodian of all the valuable papers, *securely* keeping the same under the name of the district in the fireproof vault.
- 6.1.8 Report regularly to the executive team leader. *Chief Operating Officer*, to the Board of Directors, and to the District Convention on matters of the district budget and finances.

7.0 CIRCUIT FORUMS (Remove this section entirely. Covered by Synod Bylaws 5.3 – 5.4)

7.1 Statement of Purpose

- 7.1.1 The Circuit Forum shall serve as a setting to review and evaluate programs, plansand long-range directions of the district and the Synod and thus participate in the triennial process of suggesting, developing and attaining the Synod's priorities andgoals.
- 7.1.2 The Circuit Forums shall examine the needs of the congregations within their circuits, and their general community, and relate these needs in a written format to the districtpresident's office, at least two (2) months prior to the district Goal Setting Conference.
- 7.1.3 The Circuit Forum shall invite the district president, or a member of his staff, to attend one Circuit Forum meeting every three years in order to share the hopes andneeds of circuit, the district, and the Synod.

7.2 Organization and Meetings



- 7.2.1 Each Circuit Forum shall consist of one pastor and one lay member from each congregation of the circuit. The circuit lay delegate to the Synodical Conventionshall function as an advisory member.
- 7.2.2 Additional officers, as required, shall be elected by the Circuit Forums.
- 7.2.3 The circuit counselor shall ordinarily serve as the chairman of the circuit forum, providing guidance, direction, coordination to the plans and programs, which theforum intends to implement.
- 7.2.4 The Circuit Forum membership shall be elected by the congregations in the yearfollowing the district convention.
- 7.2.5 The chairperson of each Circuit Forum shall be the presiding officer of all CircuitForum meetings.
 - 7.2.6.1 In the absence of the chairperson, the forum shall be empowered to appoint an acting chairperson from its membership.
- 7.2.6 Each Circuit Forum may appoint Standing Committees as needed.
 - 7.2.6.1 As specific needs arise, additional standing committees may be ormed at the discretion of the Circuit Forum.
 - 7.2.6.2 Standing committee chairpersons shall be appointed by the chairperson of each Circuit Forum.
 - 7.2.6. These standing committees shall research the needs of congregations in their circuit and implement district programs, or design programs of their own, to meet these needs.
 - 7.2.6.4 The standing committees shall report to their Circuit Forum at each regularmeeting.
- 7.2.7 Each Circuit Forum meets as follows:
 - 7.2.7.1 The Circuit Forum shall meet at least four (4) times per year or as often asnecessary to plan and carry out its responsibilities.
 - 7.2.7.2 The chairperson shall be empowered to call special meetings as required.
 - 7.2.7.3 Standing committees shall meet during regular Circuit Forum meetings andas often as necessary to plan and implement programs.



8.0 STANDING COMMITTEES

8.1 Committee on Constitutions

- 8.1.1 The district shall elect a Committee on Constitutions composed of two ordainedministers and one layman.
- 8.1.2 All new and revised constitutions of the congregations the district are to be reviewedby this committee, in accordance with the synodical Bylaws.
- 8.1.3 The Committee on Constitutions shall examine the constitution and bylaws of congregations to ascertain that they are in harmony with Holy Scripture, the Confessions and the teachings and practices of the Synod in order that any necessary changes may be made by the congregation before the application isacted upon.
- 8.1.4 If at any time there is a disagreement between the committee and the congregationapplying for membership on any scriptural doctrine or Synod policy that cannot be resolved by the district president or Board of Directors, and if the Board of Directors denies the application, the district president shall submit the application to the next convention of the district (Synod Bylaw 2.3.1 [c]).
- 8.1.5 The committee will also suggest such improvements in congregations and organizations constitutions and bylaws as will better serve the administration of their affairs.

8.2 Mission Committee

- 8.2.1 The Mission Committee shall consist of a representative from each region appointed by the district president in consultations with the region's vice president.
- 8.2.2 The committee shall assist the regional directors and vice presidents in enabling the congregations to carry out the mission activities of each region and the district.

8.2 District and Regional Mission Councils

8.2.1 The District Mission Council (DMC) shall consist of a representative from each region and each special affinity circuit (Affinity Circuits can be gatherings of specific culture pastors, groups reflecting similar ministry environments - large church or small church pastors, pastors engaged in church planting, etc.) appointed by the district



president in consultations with the regional vice presidents and the district mission and ministry staff.

- 8.2.2 The District Mission Council (DMC) shall assist the district president and staff in setting the overall district mission strategy and equipping the Regional Mission Councils, circuits, local congregations, and schools to carry out the mission activities within the district in each region. The DMC will report on the status of all mission activity to the district president and board of directors.
- 8.2.3 The Regional Mission Councils (RMC) shall consist of a representative from each electoral and affinity circuit operating in the region. The RMC Chair shall be appointed by the district president in consultations with the local RMC members, regional vice presidents and the district mission and ministry staff.
- 8.2.4 The Regional Mission Councils shall assist the district president and staff in the local distribution of an annual budget allocation from the District Board of Directors. The RMC will provide ongoing encouragement and support to all grantees, connections to coaching and mentoring, as well as accountability for the proper use of funds. The RMC will report on the status of all mission activity to the DMC.
 - 8.3 Church Extension Committee
- 8.3.1 The District Convention shall elect a chairperson who shall be a layperson. The remainder of the committee, as at a minimum, shall consist of at least one ordained minister who is currently serving a congregation of the district who is a member of the Pacific Southwest District and one representative from each region. Each is appointed by the district president LCEF District Vice President in consultation with the region's vice president district president. All appointments are to be subject to consultation with the LutheranChurch Extension Fund vice president for the district.
- 8.3.2 The committee shall assist congregations by approving real estate loans inconformity with the policies of Lutheran Church Extension Fund.
- 8.3.3 The committee shall assist congregations by having developed and implemented a program to encourage individuals and congregations to participate and invest in the Lutheran Church Extension Fund.
- 8.4 Youth & Family Ministry Committee
 - 8.4.1 The committee shall provide planning and leadership for district youth & family ministry events and training events/conferences.



- 8.4.2 The committee shall provide an avenue for youth selected for District LYF (Lutheran Youth Fellowship) Youth leadership positions to be involved in leadership experiences.
- 8.4.3 The council committee membership:
 - 8.4.3.1 The chairperson shall be nominated by district staff and appointed by the District President.
 - 8.4.3.2 One adult representative each from Arizona, Nevada and California be nominated by the area DCE groups committee.
 - 8.4.3.3 Six high school youth, selected recruited to district LYF youth committee positions through district youth ministry events or trainings.
 - 8.4.3.4 Project directors and coordinators, selected by the Youth & *Family* Committee, to serve as committee chair or coordinators for district youth activities.
- 8.4.4 The committee shall normally meet three times a year.
- 8.5 Committee on Stewardship
 - 8.5.1 The District President shall appoint a District Committee on Stewardship to work inconjunction with the Synod's Department of Stewardship to assist and advise localcongregations with the development and promotion of an adequate stewardship program.

9.0 TASK FORCES

- 9.1 Task forces may be developed for specific purposes at the discretion of the district president, regional mission facilitators, Board of Directors, or standing committees. Task forces function under the direction of the person or group that appointed them. The task forces may be regional or for the district as a whole.
- 9.2 Task forces should be chartered with a specific purpose and task and include aspecific ending time.

10.0 PARI IAMENTARY AUTHORITY

10.1 The Constitution and Bylaws of the Synod, the Bylaws of the District, any special rules of order the District may adopt, and the rules contained in the current edition of Robert's Rules of Order, Newly Revised shall govern the district as parliamentary authorities wherever they are applicable and in decreasing order of precedence as listed.

11.0 SPECIAL RULE OF ORDER



- 11.1 The following special rule of order shall apply to the proceedings in the district:
 - 11.1.1 If a substitute motion is made and seconded the presenter shall be offered two minutes to provide the rationale for presenting the motion. The convention shall then first decide by majority vote without debate whether ornot to consider the substitute motion. If the decision is in the affirmative and the substitute motion is subsequently adopted, the original motion fails; if thesubstitute motion does not receive favorable action either to consider or to adopt, the original motion is again before the convention.

12.0 AMENDMENTS TO THE BYLAWS

- 12.1 These Bylaws may be amended as follows:

Such amendments shall be drafted by the District Secretary in partnership with the District Committee on Constitutions and shall be reviewed in advance by the LCMS Commission on Constitutional Matters.

To reject racism, rectify past wrongs of commission and omission, and recognize the Pacific District successes, failures, and opportunities in ministry within communities.

WHEREAS, God has created all people and they are blood related going back to our mutual fathers, Adam and Noah, and all are subject to the stain of original sin, but now also have been equally redeemed by the blood of Christ in order to be reconciled to God and to each other; and

WHEREAS, The Lutheran Church - Missouri Synod (LCMS) abhors racism, and in convention has passed resolutions repudiating all racism; and

WHEREAS, The Synod in convention (2019 Resolution 11-04A, "To Affirm the Common Humanity of All People and Ethnicities") resolved, "That the members of the congregations of the Synod be encouraged to work toward racial reconciliation and equality within the Church and within society-at large"; and

WHEREAS, We appreciate and recognize the work of the Commission on Theology and Church Relations in their 1994 study, "Racism and the Church: Overcoming the Idolatry", further research and study is necessary; and

WHEREAS, The legacy of racism enacted through prejudice and discrimination has negatively impacted the needs, well-being, income, and property of people based solely on the color of their skin; and

WHEREAS, The people of God are striving to live faithfully, but still participate in sinful thoughts, words, and deeds in what they do and leave undone (1 John 1:8-10), which can and has included the sin of racism; and

WHEREAS, Jesus tells us that the greatest commandments are to love God and love your neighbor (Mark 12:30-31); and

WHEREAS, Jesus illustrates for his disciples that they are to treat all persons as neighbor (Luke 10:29-37); and



WHEREAS, Paul exhorts us to show the love of Christ as we "bear one another's burdens" (Galatians 6:2); and

WHEREAS, Martin Luther extolls us to show that love as we care for our neighbors as we support them in their needs, well-being, income, and property in his explanations of the fifth and seventh commandments; and

WHEREAS, In order for the Pacific Southwest District to better engage acts of reconciliation and equality it should be informed of its history within communities **-of color** to understand its successes and its failures; therefore be it

Resolved, That the Pacific Southwest District reject any teaching that:

- •One's race, ancestry, or nationality are inherently superior to the race, ancestry, or nationality of another.

WHEREAS, the congregations of the Pacific Southwest District – LCMS acknowledge that there is a growing need for well trained, general ordination pastors who are able to receive divine calls from congregations without restriction, provide supervision for other rostered church workers, supervise vicars, hold elected or appointed office on the district or national Synod level such as a Circuit Visitor, and vote as delegates at the Synodical conventions of the church; and

WHEREAS, pastors of the Lutheran Church-Missouri Synod are retiring in larger numbers than ever before (estimated 1/3 of our Congregations will be without a Pastor by 2035) and the number of men entering our seminaries is less than what is needed to replace these faithful servants and expand further mission and ministry; and

WHEREAS, most students in today's world of education expect that they will be afforded the opportunity to learn in a variety of educational methods which include both online as well as in-person instruction; and

WHEREAS, it has become increasingly difficult and prohibitive for prospective LCMS seminary students to leave homes, family, employment, and ministry context to move cross-country to enroll in a four-year residential Master of Divinity program; and

WHEREAS, the Cross-cultural Ministry Center at Concordia University Irvine has, for 27 years, faithfully offered the only Master's-level degree in the LCMS with a hybrid model of online and in- person education leading to general ordination with certification through Concordia Seminary St. Louis; and

WHEREAS, enrollment in the Cross- cultural Ministry Center is currently limited by: 1) A total enrollment of 29 students in the program; 2) where those students are geographically located (LCMS Region 5 – Western US); and 3) A seemingly narrow definition of "culture crossing" that is required for enrollment, be it therefore

RESOLVED, that the Pacific Southwest District memorialize the 2023 LCMS Convention to direct Concordia Seminary St. Louis to remove the current limitations for the Cross-cultural Ministry Center (number of students, geographical locations of students, and criteria for culture-crossing ministries) to enable more men to prepare for the pastoral ministry.

RESOLUTION 22.1.2 To create a third pathway for general pastoral colloquy for members of LCMS congregations who have graduated with an accredited Masters of Divinity Degree from a non-LCMS Seminary

Rev. Ron Burcham, chair. Rev. Dan Chrismer, presenting.

WHEREAS, God's Word call us to pray for additional workers in the harvest, "When he (Jesus) saw the crowds, he had compassion for them, because they were harassed and helpless, like sheep without a shepherd. Then he said to his disciples, "The harvest is plentiful, but the laborers are few; therefore pray earnestly to the Lord of the harvest to send out laborers into his harvest;" (Matthew 9:36-37, ESV); and

WHEREAS, pastors of the Lutheran Church-Missouri Synod are retiring in larger numbers than ever before (estimated 1/3 of our Congregations will be without a Pastor by 2035) and the number of men entering our seminaries is less than what is needed to replace these faithful servants and expand further mission and ministry; and

WHEREAS, the congregations of the Pacific Southwest District – LCMS give thanks to God and celebrate the various alternate routes to ordination and pastoral ministry available in the LCMS, such as Specific Ministry Pastors (SMP), there is a growing need for general ordination pastors who are able to receive divine calls from congregations without restriction, provide supervision for other rostered church workers, supervise vicars, hold elected or appointed office on the district or national Synod level such as a Circuit Visitor, and vote as delegates at the Synodical conventions of the church; and

WHEREAS, there are pathways by which pastors, from church bodies outside the Lutheran Church-Missouri Synod, who meet specific criteria may secure admission to the ministerium of LCMS as general ordination pastors through Colloquy. This admission may be provided through a "colloquy" (discussion, interview) with the Colloquy Committee for the Pastoral Ministry; and

WHEREAS, The Policy Manual for Admission to the Pastoral Ministry of The Lutheran Church—Missouri Synod by Colloquy: Bylaws and Policies states:

To be eligible to apply for colloquy, applicants must fit into one of the categories listed below (the applicant will indicate under which category he is applying, but the Colloquy Committee for the Pastoral Ministry is responsible for the final determination of the category in each individual situation):



Men who, at the time of application are in good standing and in active service as pastors in another Christian Church body/denomination may apply for colloguy. Such applicants must be graduates of a program of study that leads to ordination, from an accredited institution, with no fewer than 60 semester hours (90 quarter hours) of required academic credit. Such applicants must also have served at least three years in a recognized ministry of their church body.

Active Pastors from Other Christian Church Bodies:

1.

- Applicants must supply suitable documentation of their active status and good standing in their current church body/denomination. Pastors of congregations that are not affiliated with a church body/denomination (are "non-denominational" or "independent") also may apply, but they must supply suitable references and documentation of their authorization to perform pastoral ministry. In all cases the academic requirements will apply.
- 2. Men Who Have Prepared for Pastoral Ministry but, at the Time of Application, Are Not in Active Service as Pastors: Such applicants must be graduates of a program of study that leads to ordination, from an accredited institution, with no fewer than 60 semester hours (90 quarter hours) of required academic credit. Applicants with prior pastoral service must provide the date (month and year) and the reason (e.g. retirement, resignation, dismissal) their active service ended. References and suitable documentation will be required. Such an applicant also must have been a communicant member in good standing in a congregation of The Lutheran Church—Missouri Synod for at least two years* immediately prior to the time of application.

WHEREAS, Men who have been long-time members in good standing in a congregation of The Lutheran Church-Missouri Synod, but are graduates of programs of study leading to ordination from an accredited institution outside the Lutheran Church-Missouri (meeting all the necessary academic credit requirements), are not afforded the same opportunity to apply for Colloguy as are pastors from church bodies outside the LCMS, but must enroll in the Residential Alternative Route Program (requiring a two year residential academic program at one of our two seminaries and a one year vicarage) before becoming a general ordination pastor in the LCMS;

WHEREAS, requiring a residential program for individuals who have completed an accredited degree is cumbersome and burdensome to many, be it therefore

RESOLVED, that the Pacific Southwest District memorialize the 2023 LCMS Convention to create a third pathway for general pastoral colloguy that provides the opportunity for members of LCMS congregations who have graduated from programs of study leading to ordination from outside the seminaries of the LCMS (satisfying all the necessary academic credit requirements) to become general ordination pastors in the



LCMS by way of the Colloquy process, without enrolling in the Residential Alternative Route Program.

RESOLUTION 22.1.6 To Reconsider the Use of the Licensed Lay Deacons in Word and Sacrament Ministry

Rev. Ron Burcham, chair. - Mrs. Annie Anderson, presenting.

WHEREAS, there is an increasing number of congregations who are unable to support a pastor and his family on a full time basis, and,

WHEREAS, Licensed Lay Deacons served effectively in the Synod from 1989-2016 (with a short pause), and

WHEREAS, the Synod has changed its position on the use of Licensed Lay Deacons in Word and Sacrament ministry a number of times during these years: 1989, ministry of LLDs established at Synod convention (res. 3-05b); 1995, ministry of LLDs taken back (res. 3-07a) by requiring LLDs to apply for colloquy; 2001 - ministry of LLDs resurrected (res. 3-08b) and calls for DELTO oversight committee; 2007, SMP put into play; 2016, LLDs severely limited (res. 13-02a), and

WHEREAS, the number of congregations facing shared ministry or potential closure continues to increase, and



WHEREAS, the present technological resources available to congregations make supervision of Licensed Lay Deacons by Ordained Ministers more accessible and effective, and

WHEREAS, the Lutheran Church- Missouri Synod affirms the Word of God and the work of the Holy Spirit calls people to faith in Jesus Christ and sustains them in that faith, therefore be it

RESOLVED, that the Pacific Southwest District would memorialize the 2023 LCMS Convention to establish a Task Force to reconsider the use of Licensed Lay Deacons in Word and Sacrament ministry within its congregations, and be it further

RESOLVED, that members of the Task Force specifically include Districts that have historically made extensive use of Licensed Lay Deacons in Word and Sacrament ministry, and be it further

RESOLVED, any use of Licensed Lay Deacons in Word and Sacrament ministry must occur under the direct supervision of an Ordained Minister, and be it finally

RESOLVED, that the appointed Task Force study the document, Workers for His Harvest, submitted by the Northwest District Board of Directors following the 2016 Synod Convention.

WHEREAS, Jesus said, "The Harvest is plentiful, but the laborers are few; therefore, pray earnestly to the Lord of the harvest to send out laborers into his harvest." (Matthew 9:37-38); and

WHEREAS, Jesus set an example of what a robust theological education looks like by teaching his disciples theology while they were, at the exact same time, engaged in real-world, real- time, hands-on ministry with him; and



WHEREAS, the Apostle Paul educated and raised up new pastors and leaders by inviting them to join him and assist him and work alongside him in real- world, real-time, hands-on ministry; and

WHEREAS, God is bringing thousands of new immigrants to our communities and thereby providing our congregations with new and vast harvest fields; and

WHEREAS, our Pacific Southwest District pastors and congregations are identifying new potential pastoral leaders in and among these immigrant, non-Anglo communities; and

WHEREAS, the pool of men who are interested in and gifted for pastoral ministry and who are, at the same time, able to give up jobs, sell homes, and relocate their spouse and children to either St. Louis, Missouri or Ft. Wayne, Indiana continues to get smaller; and

WHEREAS, an unintended consequence of synod promoting residential seminary education as the preferred option for the preparation of men for pastoral ministry (2019 LCMS Resolution 6-02) is that non-residential, immigrant students receive, proportionally, a lower percentage of tuition aid from the seminary to cover the costs of their academic programs than do residential students; and

WHEREAS, pastors of the Lutheran Church-Missouri Synod are retiring in larger numbers than ever before (estimated 1/3 of our Congregations will be without a Pastor by 2035) and the number of men entering our seminaries is less than what is needed to replace these faithful servants and expand further mission and ministry; be it therefore

Resolved, That the District in convention encourage its pastors, leaders, and congregations to continue to cultivate, from our immigrant, non-Anglo communities, new leaders who are intentionally engaged in the mission of God, and be it finally

Resolved, That the Pacific Southwest District in convention memorialize the 2023 LCMS Convention to encourage the seminaries to maintain and strengthen their non-residential, learning-in-ministry, distance programs, and to award financial aid more equitably toward the students in these programs.
